5.1 Each lot received to include statements of conformity and certification. These documents must be handed in at the scales and include:

- 1) Certification for Sulfur, LOI and % >1/4"
- 2) Quantity
- 3) Name of Material
- 4) Lot Number

5.2 All chemical constituents not expressed but are contained in the subject material may not exceed 0.5% collectively. Any material lot exceeding 0.5% must have prior approval by purchasing before shipment is made and analysis included on certification.

5.3 Material is subject to inspection at North Star BlueScope Steel to test adherence to specification. Material submitted must undergo laboratory testing and operating trials prior to approval. All material supplied to this specification must be equivalent in all respects to the material on which approval was originally granted.
